

## 2025 MAC MicroGrants - Guidelines and Information

Mississauga Arts Council's (MAC) MicroGrant Program provides funding to individual artists to support the creation and presentation of their impactful projects. These MicroGrants target areas of interest or needs within the local arts sector and have been catalysts for collaboration across artistic practices.

In the Fall 2025 MicroGrant funding round, MAC offers Matchmaker MicroGrants to Individual Artists and Arts Groups. Matchmaker MicroGrants provide matching funds to artist-led projects from any artistic discipline up to a maximum of \$3000. Eligible projects must include a public-facing event or activity in Mississauga, engage audiences in Mississauga, and pay artist fees to Mississauga artists. Projects must demonstrate a confirmed investment in the project at the time of application.

# **Fall 2025 MAC MicroGrant Funding Streams:**

# Matchmaker MicroGrants\* (50% of project budget up to \$3,000)

MAC's Matchmaker MicroGrants are designed to help Mississauga creatives launch or complete an artistic project. Artists can receive up to 50% of their total project budget or \$3,000 (whichever is less) in matching funds. Artists must demonstrate confirmed revenue through sponsorship, investment, and/or in-kind contributions by the artists in their budget at the time of their application.



Eligible Matchmaker MicroGrant projects:

- Open to any artistic discipline
- Must have an accessible public-facing event or activity that benefits residents of Mississauga
- Must take place in Mississauga
- Must pay artist fees to Mississauga-based artists
- Must demonstrate confirmed sources of revenue (financial or in-kind/ volunteering) in the presented project budget
- Must indicate the career impact for the artist(s) involved
- Must illustrate the impact on the audiences/public who will experience the project
- Must include an achievable work plan

MicroGrants are intended to cover the direct costs of creation, production, operations, and related eligible project expenses. Eligible expenses might include:

- artist fees for Mississauga-based artists
- venue rental at a Mississauga location
- equipment rental and production costs directly related to the project
- marketing and promotion of the project

#### Ineligible expenses include:

- Tuition expenses for post-secondary programs
- Research projects and research-related expenses (workshop registration fees may be considered eligible, please reach out to us if you have specific questions)
- Expenses not directly related to the production of the project
- Costs related to capital projects (purchase of computers, buildings, vehicles, etc.)
- Fundraising activities or fundraising costs
- Activities occurring outside of Mississauga

**Funding Available:** up to 50% of project budget or \$3,000 (whichever is less)

# 2025 MAC MicroGrant - Applicant Eligibility:

## **Applicant Eligibility**

MAC MicroGrants are available to individual artists or arts groups living in or based in Mississauga. Applicants that do not have a Mississauga address will not be considered.

#### **MAC Membership**

Applicants do not have to be members of MAC to apply, however, if a project is successful, the recipient of the MicroGrant will need to join MAC or ensure their membership is current. (*Individual membership fees start at \$40/year*)

#### **Multiple Applications**

Applicants may only submit one (1) application. If an applicant submits more than one (1) MicroGrant Application, only their first application will be reviewed by the Peer Assessment Jury.

#### **Previous MicroGrant Winners**

Previous MicroGrant winners are eligible to apply.

Final reports for any outstanding MicroGrant projects must be received AND approved by MAC before an applicant can apply for new MicroGrant funding.

# 2025 MAC MicroGrant - Project Eligibility:

#### **Project Eligibility**

Projects must be relevant to arts and culture in Mississauga and follow the guidelines. All eligible projects must include an accessible public-facing activity or element.

#### Geography

All projects are required to take place in Mississauga or have the majority of the work completed there. **This is non-negotiable.** 

#### **Multiple Applications**

Applicants may only submit one (1) application for one (1) project. If an applicant submits more than one (1) MicroGrant Application, only their first application will be reviewed by the Peer Assessment Jury.

#### **Previously Funded Projects**

Projects that have previously received funding through any of MAC's MicroGrant or Matchmaker MicroGrant Funding Streams ARE eligible to receive additional funds but must demonstrate project growth and/or community impact.

## 2025 MAC MicroGrant Application Requirements:

Once you have carefully read these guidelines and have prepared your application materials, you can submit your application using our web form. We encourage you to gather all the information below BEFORE starting your application. **Partially completed online applications cannot be saved and edited later.**

All applications MUST be submitted through our web form. No applications by email or any other form will be accepted or considered.

The Webform Application is divided into three sections and requires the following information:

## **Section 1: Applicant Information**

#### Required:

- 1. Applicant Name & Contact Info (Email, Phone, Address)
- 2. Artist or Project website link
- 3. Document Upload: Artist CV/Resume
  - a. PDF, Doc, or Docx format only
- 4. Document Upload: Three (3) Work Samples
  - a. Upload one (1) document in PDF, Doc or Docx format only
  - b. The document should include:
    - i. links to online projects or images of your works etc.
      - Ensure any links to a Dropbox/drive are not restricted by sharing permissions
    - ii. descriptions of how the works demonstrate your ability to undertake the proposed MicroGrant Project

## **Section 2: Project Information**

#### Required:

- 4. Tell us about your intended audience and how you will reach this audience.
- 5. What are the Impact and Outcomes of the Project
- 6. Artistic Practice(s) Represented by the Project (select options)
- 7. Number of Artists Involved
- 8. Amount of Funding Requested
- 9. Proposed Project Start Date
- 10. Proposed Project End Date
- 11. Document Upload: Project Proposal
  - a. PDF, Doc, or Docx format only
  - b. Proposal should include a comprehensive description of your project, list of confirmed/proposed partners and/or artists, venues etc.)
- 12. Document Upload: Work plan/timeline for your project indicating key milestones
  - a. PDF, Doc, or Docx format only

#### Optional:

- 13. Additional Comments or Information about your project
- 14. Document Upload: Additional Supporting Documents

## **Section 3: Budget Information**

#### Required:

- 1. Document Upload: Project Budget

    - i. Do not request access to edit the document. DOWNLOAD a copy to your computer or your google drive to edit locally.
  - b. Complete your budget and save/export the completed budget
    - i. Please change the title of the document to include your name
  - c. Upload your final budget in PDF or xls format to the webform
- 2. List and briefly describe all confirmed sources of revenue for your project.

#### For previous MicroGrant winners only:

- 3. Has your project previously received a MAC MicroGrant?
  - a. If yes, please describe how your project has grown or why it continues to be impactful to audiences.

## 2025 MAC MicroGrant Assessment:

MAC Matchmaker MicroGrant applications will be evaluated by an independent jury of artists and/or arts industry professionals in Mississauga. To ensure consistency and fairness, each peer assessment jury uses the same scoring criteria and a non-voting member of MAC will audit each jury session to ensure a fair and transparent process. The decision of the jury is final and confidential.

The peer assessment committee will evaluate applications based on the following elements:

- Impact & Innovation of the proposed project
- Qualifications and Experience of Applicant to undertake the proposed project
- Connection to the Community, Audience
- Attainable Project Schedule & Work Plan
- Realistic Budget

#### Successful MicroGrant applications will:

- Be an intriguing, valuable or impactful project
- Enrich arts offerings available to Mississauga audiences
- Demonstrate a commitment to supporting the Mississauga Arts community
- Contribute to the positive career development of the artists involved
- Include a feasible schedule, budget, and project details

# 2025 MAC MicroGrants - Frequently Asked Questions

#### **How can I apply for a MicroGrant?**

#### When is the application deadline?

All MicroGrant applications must be received by MAC by Monday, October 6, 2025, by 5:00 PM. NO LATE SUBMISSIONS WILL BE ACCEPTED.

We encourage applicants to apply early to ensure their submission is received by the deadline.

#### What does "in-kind" mean?

An in-kind contribution is a non-monetary contribution or donation. This includes donated goods, services or volunteer work to support a project. In-kind contributions can include goods or services offered free of charge or at a significant discount rate (ex. Free rehearsal space, volunteer services).

#### Will MAC review my application before I submit it?

MAC can only provide advice on submission requirements. MAC will not provide feedback on the content or quality of your application.
